COVID-19 RELIEF FUNDS (CVRF) BUSINESS ASSISTANCE PROGRAM

Thank you for your interest in participating in the COVID-19 (CVRF) Business Assistance Program. Every business, large and small plays an important role in our community's economy, and we are pleased to assist you by means of this program. The Town has allocated \$150,000 for this program, qualifying businesses can apply for reimbursable expenses they have incurred after March 15, 2020 for purchases of Personal Protective Equipment (PPE), equipment/operating supplies, workspace and other physical space modifications needed to operate including tables, chairs and heaters to expand outdoor seating areas because of COVID-19. Businesses who were forced to close by State mandate or who have suffered significant financial loss due to COVID-19 are also eligible to apply. A qualifying business is one who is located within the town limits of Meeker and is registered and in good standing with the Colorado Secretary of State. Funding cannot duplicate expenses that were covered under the Paycheck Protection Program or the Town of Meeker Business Recovery Grant. These grant awards may be taxable. Deadline for applying: Oct. 30, 2020, requests will be filled on a 1st come 1st served basis until all funds are expended.
